## SECTION 4. FIRST-AID MEASURES

**First aid measures**

## SECTION 5. FIRE-FIGHTING MEASURES

**Suitable extinguishing media:** Carbon dioxide (CO<sub>2</sub>), dry chemical or water spray. Fight larger fires with water spray or alcohol resistant foam.

## SECTION 6. ACCIDENTAL RELEASE MEASURES

**Personal precautions, protective equipment and emergency procedures:** In the event of a spill or accidental release, notify relevant authorities in accordance with all applicable regulations. Keep away from ignition sources. Wear protective equipment. Keep unprotected persons away.

**Environmental precautions:** Prevent entry into sewers, waterways or confined areas by diking or impounding. Dike far ahead of spill for later recovery and disposal. Advise authorities if the product has entered or may enter sewers, watercourses, or extensive land areas.

**Methods for containment and cleaning up**

**Land spill:** Stop leak if you can do so without risk. Recover free product using non-sparking tools. Add sand, earth, or other suitable absorbent material to the spill area. Recover by pumping or with suitable absorbents. Dispose of in accordance with national and/or local regulations relating to waste disposal.

**Water spill:** Stop leak if you can do so without risk. Confine the spill immediately with booms. Remove from the surface by skimming or with suitable absorbents. Seek the advice of a specialist before using dispersants.

## SECTION 7. HANDLING AND STORAGE

**Precautions for safe handling:** Keep away from heat and direct sunlight. Ensure good ventilation/exhaustion at the workplace. In case of insufficient ventilation, wear suitable respiratory equipment. Do not breathe vapors or spray mist. Wear personal protective equipment. Avoid contact with skin and eyes. Wash thoroughly after handling.

**Conditions for safe storage, including any incompatibilities:** Store in a cool, dry place in tightly sealed containers. Store out of direct sunlight. Do not store near heat, sparks, open flame, pilot lights, static electricity, or other sources of ignition. Do not store where temperature may exceed 49°C (120°F). Store away from oxidizing agents. Rotate stock.

### **Exposure controls**
